(This is a permanent, irreversible procedure and there is no is recourse if anything ever goes wrong).

The CDC and WHO confirmed mutations lead to a weaker and more transmissible variant which means Delta and Omicron do not have the same potential for causing deaths as the original Covid-19 (wild-type or lab-made) strain. Dr. Bridle warns continual administration of vaccinations and boosters will exacerbate development of variants. No current evidence suggests unvaccinated individuals cause a rise in cases.
